Introduction

- 1. The purpose of this plan is to set out the recommended initial activities steps required after the ratification of the Governance agreement and before its effective date to prepare for the day one of the Anishinabek Governance System by the Anishinabek First Nations and Anishinabek Nation.
- 2. The parties to this Work Plan to Establish the Anishinabek Governance System (the "Work Plan") are the Anishinabek First Nations, and Indigenous Affairs and Northern Development representing the Government of Canada ("Canada"). The Anishinabek First Nations and Canada have jointly developed this plan to coordinate activities to support the establishment of the Anishinabek Governance System. The Parties anticipate this system will be operational on April 1, 2021.
- 3. The bases for this Work Plan are the Governance Implementation Plan, the Anishinabek Nation Governance Agreement and the Anishinabek Nation Fiscal Transfer Agreement.
- 4. The Anishinabek Nation Governance Agreement is a sectoral self-government agreement between the Anishinabek First Nations and the Government of Canada that deals with core governance matters including elections, citizenship, financial and administration. It also identifies matters for subsequent negotiations. On the basis of the Anishinabek Nation Governance Agreement, the Anishinabek First Nations and Canada have agreed to identify their respective activities related to setting up the Anishinabek Governance System.
- 5. The separate funding arrangements to support the implementation of this Work Plan will be addressed in an annual self-government negotiations funding Support funding Agreement between by the Union of Ontario Indians and Canada. It will not be covered by the Fiscal Transfer Agreement.

Definitions

6. In this Plan, the

"Anishinabek First Nations" are the First Nations that successfully ratified the Anishinabek Nation Governance Agreement and whose names appear in Schedule A of that Agreement;

"Anishinabek Nation Education Agreement" and "ANEA" means the agreement on education between the Anishinabek First Nations and Her Majesty the Queen in Right of Canada as represented by the Minister of Indian Affairs and Northern Development as ratified by the Anishinabek First Nations;

"Anishinabek Nation Governance Agreement" and "ANGA" means the agreement on education between the Anishinabek First Nations and Her Majesty the Queen in Right of Canada as represented by the Minister of Indian Affairs and Northern Development as ratified by the Anishinabek First Nations;

"Effective Date" means the date that the ANGA comes into legal effect under federal legislation;

"FNs" are the First Nations that successfully ratified the Anishinabek Nation Governance Agreement and whose names appear in Schedule A of that Agreement;

"FTA" means the Anishinabek Nation Fiscal Agreement

"Parties" means the individual Anishinabek First Nations, Ontario and Canada;

Legal Status of this Plan

- 7. This Work Plan does not create any legally binding obligations on the Parties.
- 8. Nothing in this Work Plan will be considered an amendment to, modification of or derogation from the provisions of the ANGA or the Anishinabek Nation Fiscal Agreement.

Work Plan Timeframe

- 9. This Work Plan covers the period of time from the ANGA Ratification date to the Effective Date.
- 10. On Effective Date, the ANGA and FTA will be implemented.

Assumptions

- 11. The assumptions made regarding this Work Plan are:
 - a. the Anishinabek First Nations will confirmed the structure of the Anishinabek Nation's Government;
 - b. the activities under this Work Plan will support the establishment of the Anishinabek Nation Governance for operation on the Effective Date;
 - c. the activities under this Work Plan will support the smooth transition from the Indian Act governance systems to the Anishinabek Governance system;
 - d. that each Party is responsible to approve only the activities attributed to that Party under this Work Plan;

- e. that each of the Parties commits to provide necessary personnel and time to implement this Work Plan; and,
- f. that parallel execution of activities is required to ensure all activities are completed prior to Effective Date.
